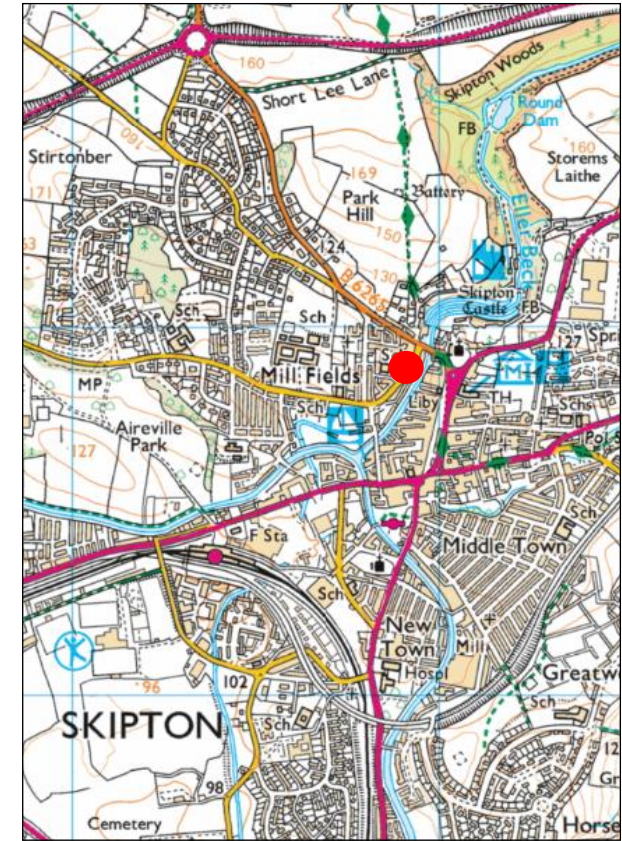

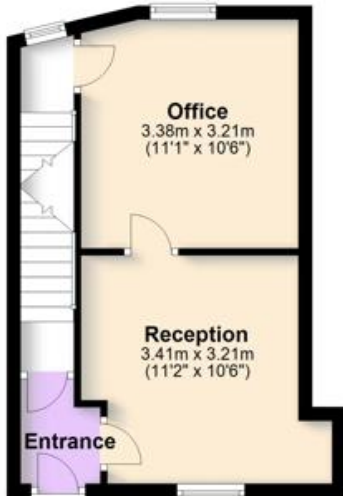

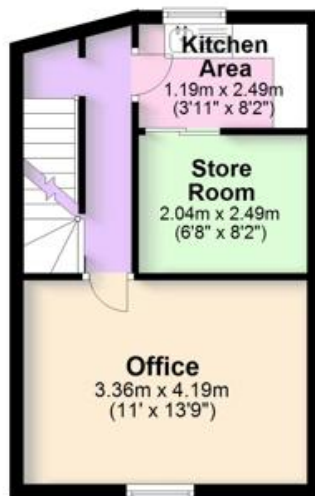
Lower Ground Floor



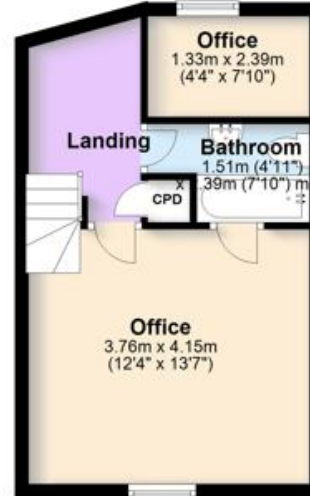
Ground Floor



First Floor

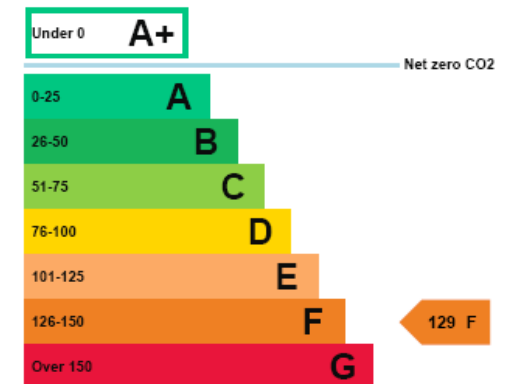


Second Floor
